Food Policy and Equity Program: Policy Papers and Policy Briefs Available

Brighter Green's <u>comprehensive</u> <u>documentation</u> on the globalization of industrial animal agriculture and climate change in four countries—Brazil, China, Ethiopia, and India—is now available. The three policy papers (India will be out soon) and four policy briefs form the foundation of our <u>Food Policy and Equity</u> Program. The completed studies also explore additional environmental, food security, equity, livelihood, and animal welfare impacts.

Food Policy and Equity Program: Videos

Brighter Green in the Classroom

This semester, Mia MacDonald is teaching a senior "capstone" seminar, "Animal Product-Based Diets and Climate Change," in New York University's Environmental Studies department. Students are developing policy proposals and a a public education campaign and toolkit for a New York City-wide "cool foods" initiative designed to be both practical and visionary.

The course draws on Brighter Green's research on the climate-effects of industrial animal production, as well as our participation in the Foodprint NYC Alliance. Brighter Green's policy paper, Skillful Means: the Challenges of China's Encounter with Factory Farming (PDF), was used by Jane Zawadowski, an American teacher, in her English and environmental studies class at Xihua University in China's Sichuan province. Mia also spoke about the climate impacts of animal agriculture in January at a conference for New York public school teachers. Click



Brighter Green In China

Brighter Green Executive Director Mia MacDonald traveled to China at the end of March for a series of presentations in Beijing and Shanghai on the role of the livestock sector in climate change, the impacts of industrial animal agriculture in the U.S., and China's expanding production and consumption of animal

products.

Her first talk was at the day-long *Beijing 2011—Summit Forum on Science and Technology for a Carbon Neutral Society* at the Chinese Academy of Social Sciences (CASS), where she spoke alongside Chinese experts on low-carbon development, as well as international colleagues <u>Dr. Robert Goodland</u>, former chief environmental advisor at the World Bank, and Gerry Wedderburn-Bishop, former principal scientist for the Queensland government in Australia. Mia also spoke to policy-makers, academics, students, and

municipal government officials at the Shanghai Academies of Social and Environmental Sciences, and at the Beijing Institute of Technology. Stay tuned to Brighter Green's website and Facebook page for more news from the China trip and next steps.

Policy Research in Translation

In an effort to make its country studies on climate change and the globalization of animal agriculture more broadly accessible, Brighter Green has published an <u>updated Chinese translation</u> of *Skillful Means* (PDF), and a <u>Chinese translation of the China policy brief</u> (PDF). Mia shared these with participants at the presentations she made in China, as well as with many other Chinese institutions and individuals. We've also translated our <u>Brazil policy brief into Portuguese</u> (PDF) and an Amharic translation of the Ethiopia policy brief will be available soon.
